**River Grove Police Officer Tony Ikis** was awarded a Certificate of Appreciation by the Alliance Against Intoxicated Motorist (AAIM) this past August. Officer Ikis has been on the River Grove Police Force for 23 years.

AAIM sent a letter and a certificate to Officer Ikis that states: "every year hundreds of people are killed and thousands injured as a result of alcohol and drug-related crashes in Illinois. It takes only seconds to become a victim – without warning or choice. impaired drivers make choices, they

choose their weapons – vehicles and alcohol or drugs. AAIM conducts its Annual DUI Survey of over 700 Illinois police agencies, with funding from the Illinois Department of Transportation, wherein we request your departments top DUI Officer. In response we ask that you pay tribute to this fine officer, as one of AAIM's Top Cops, with our congratulations. You have our sincere appreciation and heartfelt thanks for Officer Ikis' exceptional public service."

## From the Chief of Police:

Over the last several weeks, the police department has received several complaints of "mini-bikes" driving erratically and illegally on public streets, sidewalks and alleys. All residents and visitors are reminded that River Grove has an ordinance (9-17-17) prohibiting the use of motor driven cycles or electric driven cycles and scooters within village limits. Included in the motor driven cycles prohibited from use within the village boundaries are those commonly known as a "mini-bike", "moped", or scooter". Additionally, Ordinance 9-17-17 (A) goes on to define a motor driven cycle and an electric driven cycle as any motorcycle, motor scooter, motorized pedal cycle, motor driven skateboard with less than one hundred fifty (150) cubic centimeter displacement, or electric scooter, electric pedal cycle or electric skateboard, including, without limitation, any cycle or scooter that is capable of being powered by both motor or electric and human pedal power, but excluding those cycles or scooters that are only capable of being powered by human pedal power.

Persons operating an illegal motor/electric bike or scooter, within village boundaries, could be ticketed and their bike or scooter could be impounded.

## A Few Reminders From Our Code Enforcement Department

- Please pick up garbage around cans and dumpsters.
- Uncut grass, overgrown weeds and animal waste, are some of the complaints the village gets. These should be handled by the property owner before they are seen by your neighbors.
- River Grove residents are required to display their addresses on the front and rear of their property. The numbers must be large enough to read from the street or alley. The village asks residents to do this so that our police and fire departments can find homes in an emergency.
- Single family residents are allowed no more than 2 dogs and or 4 cats total. For apartment dwellers, where landlords allow pets there can be no more than 1 dog and or 2 cats total. There is no mixing of these numbers.
- Animals should be registered with the village, the fee is \$5 and you receive a tag.
- Residents are to purchase pre-paid Village of River Grove Waste Tags for additional waste and large items that are set out for collection outside the 96-gallon refuse cart which has been provided each residence. Village Waste Tags are available for purchase at the following cooperating merchant locations. These merchants are selling the tags as a community service to River Grove residents. These merchants receive no revenue from the sale of the tags; therefore, cash purchases are appreciated. ADA's European Market & Deli, 8301 West Grand Avenue, BP Gas, Mart & Mc Donald's, 8800 Grand Avenue (River Road & Grand), Village Hall, 2621 North Thatcher.
- Residents can drop off electronics for recycling on the first Saturday of the month from 9 a.m. to Noon at the Public Works yard located at 2101 N. West Street.
