## Winter Holiday Fire Facts shared by the River Grove Fire Department

### Christmas Trees

- U.S. fire departments respond to an average 160 home fires that started with Christmas trees per year.
- Electrical distribution or lighting equipment was involved in (44%) of home Christmas tree fires.
- Christmas tree fires, some type of heat source, such as a candle or equipment, was too close to the tree.

### Holiday Decorations

- U.S. fire departments respond to an estimated average of 780 home structure fires per year that began with decorations.
- The decoration was too close to a heat source such as a candle or equipment.

### Candles

- Candle fires started when something that could burn, such as furniture, mattresses or bedding, curtains, or decorations, was too close to the candle.
- The two peak days for candle fires were Christmas and Christmas Eve.

### Holiday Cooking

- Thanksgiving is the peak day for home cooking fires, followed by Christmas Day and then Christmas Eve.
- Cooking equipment was involved in one of every five (19%) of home decoration fires. This can happen when a decoration is left on or too close to a stove or other cooking equipment.

## Cook County Provides COVID-19 Relief Funding For River Grove

Cook County received approximately \$429 million from the U.S. Treasury from the **CARES Act**. Under the Act, units of local government with a population exceeding 500,000 are eligible to receive this funding and can distribute these funds to municipalities under this threshold for direct expenses related to coronavirus. Per the CARES Act, these funds are NOT eligible for loss of revenues many local jurisdictions are unfortunately facing and only authorized for direct COVID-19 expenses. Cook County allocated \$51 million of this relief among the municipalities located within Cook County. The Village of River Grove was allocated \$458,814 in September 2020 and an additional \$12,000 in October 2020.

Allocations to each municipality were determined through an equitable lens, with factors that included, but that were not limited to the following: immediate needs of the municipality to respond to the pandemic, municipal population, municipal median income and municipal public health statistics. It is important to note that each municipality was required to apply for this funding allocation and such allocation were contingent on eligible cost reimbursement. Expenditures submitted by the Village for reimbursement under this agreement were regular salaries incurred by public safety personnel (police and fire) for the period from March 1, 2020 to August 31, 2020. This partial reimbursement of public safety salary expenditures allowed the Village, which is facing financial pressure due to the pandemic, to prevent furloughs or lay-offs of employees who are needed to assist with the Village's response to the COVID-19 public health emergency. This funding allowed the Village to maintain current service levels provided to the entire population of the Village. The Village of River Grove extends its sincere gratitude to the Cook County administration for providing this opportunity to participate as a sub recipient of the Corona Virus Relief Funds.

During the month of November, Mayor Guerin, the Village Officials and the RGFD sponsored an event where Flu shots were available to R.G. Seniors and Staff. The Village hosted a blood drive with the American Red Cross 2 days later. Twenty-four first time donors participated along with many others. **We want to thank all who participated!**
