It is the mission of the Village of River Grove Recreation Department to provide a youth program that fosters good sportsmanship, teamwork, healthy competition and a positive learning experience.

- I will not use vulgar language or gestures.
- I will respect all coaches, officials, players and spectators both on my team and other teams.

- I will respect the decisions of the coaching staff and will not approach them with my concerns during practices or games (if needed the coach may invoke a twenty-four hour cooling off period).
