From the Building Department: Snow Removal

(A) Each owner or occupant of any premises shall keep the sidewalks abutting the premises free from snow and other obstructions. In the event that an owner or occupant of any premises is unable to maintain abutting sidewalks in such condition, the owner or occupant shall advise the Public Works Department in writing of the inability to perform such maintenance.

(B) It shall be unlawful for any person, in any manner, to deposit snow on any street, alley or other public thoroughfare within the Village.

(C) If any plowing of private driveways or parking lots is undertaken, any snow plowed from these areas shall be piled on the private property of the owner of these areas, and shall not be piled on any public street, alley, parkway or other public thoroughfare.

(D) Any person who violates this section shall be subject to a minimum fine of fifty dollars (**\$50.00**), and up to seven hundred fifty dollars (**\$750.00**) for each violation. (Ord. 2011-18, 9-1-2011)


River Grove Senior Snow Removal Program

The Village of River Grove and East Leyden High School students have partnered to assist River Grove senior citizens with snow removal. A shovel may need to be provided, the Village will verify with the students. The rate will be \$10.00 per house and includes the following:

- A path from your front door to your sidewalk/street/stairs
- A path from your back door to your garage door
- Additional charges will apply for the following and will be discussed and handled with the student that is assisting you:
 1. Salting (resident must provide salt)
 2. Shoveling driveways, carport, parking space(s)

Payment must be made at the time of service.
