## Quiet Zone Update from the Village Engineer

Last month the Village continued to get closer to establishing a Quiet Zone in River Grove. The Village's contract with Superior Road Striping is well underway, with delineators and signage having been put in place. The remaining work item is the improvement to pavement markings. This work is dependent on weather and temperature so it will occur in late March of this year. Once the pavement markings are completed, the Villages of River Grove and Franklin Park will file their notices to the FRA, ICC, IDOT and the railroads, informing them that the safety measures required to meet the establishment of the Quiet Zone have been installed. After a thirty-day period the Quiet Zone will be established. Until the Quiet Zone is officially established, trains are required to blow their horns when at a roadway crossing.

**After the Quiet Zone is established, trains will still blow horns under the following conditions.**

- When a vehicle, person or animal is on or near the track and the crew determines it is appropriate to provide warning.
- When there track or construction workers are within 25 feet of a live track.
- In other emergency cases.

## CMAP Comes to River Grove

Mayor Guerin introduced the CMAP (**The Chicago Metropolitan Agency for Planning**) team as they presented to a full house at the River Grove Community Center last month. The informative presentation called for a great deal of input from the residents. They were broken out into groups and went to different areas to discuss what is most important to them to keep River Grove viable and what is needed to bring us into the future. Those areas included: Economic Development, Transportation, Parks & Environment, what people liked most about RG and what they would change. The CMAP team will now take this information back to compile the recommendations and to work on a comprehensive plan for River Grove.

## A Few Reminders:

### From LRS (Lake Shore Recycling) the Village's garbage hauler:

**BULK ITEMS:** Bulk items (that do not fit into your refuse cart) are collected loose, on your regular day of service. If an item exceeds 50lbs, residents may need to call **LRS (773-685-8811)** to schedule a special pickup. If a "bulk" item is considered hazardous, unacceptable for landfills or deemed unacceptable to take as garbage, the item(s) will not be taken.

**MATTRESS/BOX SPRING:** Mattresses and box/bed springs are required to be in a plastic mattress cover and taped securely shut. Plastic mattress covers may be purchased at retail outlets such as Walmart, Lowes, Menards, Home Depot and storage unit facilities. Each bulky item requires one waste sticker to service.

## From Village Code Enforcement:
