## FIRE SAFETY

I am happy to announce that the fire department will be taking delivery of a new fire engine within the next 30-40 days. In response to an urgent situation, President Guerin and the Village Board took quick and decisive action to acquire a new fire engine in order to secure continued and uninterrupted emergency service to our community.

The new engine is a 2017, "E-One" that has been used as a demonstrator for the last several months. After researching a number of options, it was determined that purchasing a "demo" - as opposed to ordering a new vehicle - provides considerable monetary savings as well as much quicker delivery time. The new vehicle will be covered under all the warranties that would be afforded to a new vehicle. Additionally, the fire department is currently working with the manufacturer on modifications that will fit the specific needs of the department.

This purchase will represent the first new fire engine acquisition since 2001, and will be a welcome addition to the current fleet.

## SENIORS WATCH YOUR MAIL

Residents over the age of 65 who own and reside in their home are annually eligible to apply for the Cook County Senior Homeowner Exemption that reduces the property tax bill on the property they reside. We have been advised that the office of the Cook County Assessor will have mailed the application forms the week of January 15th and seniors are advised to complete and return them to the assessor by the February 7th deadline. Eligible seniors who have never applied for the Senior and/or Senior Freeze Exemptions in the past will also be able to visit the Assessor's web site at [www.cookcountyassessor.com](http://www.cookcountyassessor.com) and download an application or contact the Assessor's Office at **312-443-7550** and request a form be mailed to them.
